## Secondhand Alcohol Harms

**WE ALL KNOW** about the harmful effects of secondhand tobacco smoke. There is also harm from exposure to secondhand alcohol. Alcoholic drinks not only affect drinkers themselves, but also their partners, families, and many in the public as well.

A carefully conducted nationwide survey has just been published that documents alcohol's secondhand harm in the United States.<sup>1</sup> Alcohol costs people other than the drinker, time, money, and peace of mind. It affects people's physical and mental health as well as their quality of life. The societal costs of alcohol are estimated to be twice those incurred by drinkers themselves.

Women report marriage and family harm as well as financial strains from other drinkers. Men are more likely to be assaulted by other drinkers and to be passengers in the cars of drunk drivers that end up in crashes. Those most often harmed by alcohol are unmarried, unemployed, and of low income.

The harms documented in this study include: (1) being harassed, bothered, called names, or otherwise insulted; (2) having clothing or belongings ruined; (3) feeling threatened or afraid; (4) having house, car, or other property vandalized; (5) being pushed, hit, or assaulted; (6) being physically harmed; (7) being in a traffic accident; (8) being a passenger in a vehicle with a drunk driver; (9) having family problems or marriage difficulties; and (10) having financial trouble.

Here is a table showing the percent of men and women in the United States affected by several of these secondary alcohol related harms. The projected total number of people affected are given in the second column. These data are for a single year. Since harms occur intermittently and over several years the numbers are worse than projected in this table.

### Past-year prevalence of types of alcohol's harm to men and women

HARM TYPE	PERCENT AFFECTED	NUMBER AFFECTED
Harassment/threats	16.3%	39.7 million
Property/vandalism	5.1%	12.3 million
Physical aggression	3.9%	9.5 million
Driving related	6.3%	15.2 million
Family & financial	4.2%	10.3 million
Any alcohol harm	22%	53.3 million



Both alcohol and tobacco are “legal” drugs. What a sad toll of harm to society are caused by these lethal drugs. Unfortunately, there are legislative actions to legalize additional harmful substances. Only time will reveal the harms of legalizing the use of toxic substances.
